Enrolment for Finance Boot Camp

The application deadline for the course is set at **April 30, 2018**. Please note that we accept applications of **Bachelor** and **first year Master students** studying non-finance programmes in Germany and around the world that are seeking to develop and/or deepen their financial skills in one of Europe's leading financial centres, Frankfurt am Main.

Enrolment

Selected applicants will be notified of their acceptance within two weeks after reception of their application form. After receiving the notification of acceptance, the applicant should pay a prepayment of 20% fee within two weeks. Please note that if you need a visa to stay in Germany, you have to apply at the German Embassy for a visa immediately after receiving the notification of acceptance.

Cancellations and Refunds

Any cancellations have to be made 30 days prior to start of the course, and any fees paid by that date will be refunded (less a transaction fee of EUR 30). Fees for later cancellations will only be refunded if a waitlisted applicant may take up the place, or the cancelling applicant is able to identify another person to replace him/her.

Costs and Payment Details

The fees for our Finance Boot Camp 2018 are EUR 3,400. This includes company visits and cultural trips, accommodation in boarding houses, food and local transportation (Excl. flights).

Our Summer School is fully tuition-based and not sponsored. Accordingly, participants must cover the full costs of the training and/or find a sponsor for their participation.
