

## **PARENTAL GUIDANCE CONCERNING THE PARTICIPATION OF MINORS FOR THE SUMMER SCHOOL PROGRAM**

Dear Parents,

Your child is a minor and thus, according to Article 106 of the German Civil Code (hereinafter "**BGB**"), not fully legally competent. Consequently, when making declarations of intent conferring more than purely legal benefits, according to Article 107 BGB your child also requires your consent pursuant to Articles 182 and 183 BGB. To ensure that the Summer School at Frankfurt School of Finance & Management gGmbH (hereinafter "**Frankfurt School**") runs as smoothly as possible, we therefore ask you to provide your child with your general consent for all legal transactions that may arise during and as part of this event by signing the following declaration.

**Please submit the signed general consent form (see overleaf), together with copy/copies of your identity card(s) or passport(s).**

The consent covers all event-related activities, your child's independent exercise of all rights and obligations as a participant in the Summer School program, as well as the performance of all associated legal transactions, plus any actions resembling legal transactions inasmuch as they relate directly or indirectly to participation in the Summer School.

At the same time, by giving your consent, you acknowledge that the custodial duty of care for your child as a minor continues to be incumbent upon you and not upon Frankfurt School, its members, associates, employees or other persons acting on its behalf. Furthermore, you hereby acknowledge that any liability on the part of Frankfurt School is expressly excluded.

Furthermore, we ask for your consent that all correspondence from Frankfurt School may be sent directly to your child. With respect to the use of the library and IT services, we expressly draw your attention to the following: Your child will have the opportunity to use Frankfurt School's library and IT services. This includes unrestricted access to the Internet. Frankfurt School takes no personal or technical precautions to ensure the protection of minors. By submitting this declaration, you acknowledge that neither Frankfurt School, its members or employees, associates, representatives or other persons acting on its behalf, are responsible for complying with the Youth Protection Act as it may apply to your child; instead, such compliance continues to be your responsibility.

may participate fully and without restriction in all event-related activities during the Summer School week from July 14th to July 18th, 2025, and that s/he shall moreover take full responsibility for exercising all his/her rights and obligations as a participant in the Summer School week and shall perform all associated legal transactions and/or actions resembling legal transactions inasmuch as they relate directly or indirectly to participation in the Summer School (general consent).

This general consent also expressly covers my child's participation on his/her sole responsibility in voluntary activities and events at Frankfurt School, including in particular participation in events, general university sports events, and events organised by the enrolled student body.

With this general consent, I/we furthermore acknowledge that the legal duty of care for my/our child during his/her visit to Frankfurt School shall not be incumbent upon Frankfurt School, its members or employees, associates, representatives or other persons acting on its behalf, but that the custodial duty of care for my/our child as a minor shall continue to be incumbent on me/us and I/we shall ensure that the legal duty of care is fulfilled insofar as we consider supervision to be necessary.

With respect to the use of the library and IT services, I/we acknowledge the following: my/our child has the opportunity to use the Frankfurt School library and Frankfurt School's IT services. Following the submission of this declaration of general consent, my/our child shall be given user authorisation for the

library and IT services, including Internet access. Access to the Internet is unrestricted. Frankfurt School takes no personal or technical precautions to ensure the protection of minors and cannot guarantee that my/our child shall not be able to access to adult content. I/we hereby acknowledge that neither Frankfurt School, its members and employees, associates, representatives or other persons acting on its behalf are responsible for complying with the Youth Protection Act as it may apply to my/our child, but that such compliance continues to be my/our responsibility.

This also applies to the duty of care to ensure that my/our child complies with the provisions of the Youth Protection Act relating to the consumption of alcoholic beverages and attendance at events organised by Frankfurt School. Young people under 16 years of age may not attend dance events unaccompanied by a guardian or chaperone, and young people over 16 years of age may only attend such events until midnight at the latest. Young people under 16 years of age may not consume alcoholic beverages unaccompanied by a guardian or chaperone, and young persons under 18 years of age may not consume alcoholic beverages containing spirits under any circumstances. I/we shall ensure that my/our child complies with the provisions of the Youth Protection Act.

With this declaration, I/we release and indemnify Frankfurt School from any liability. Claims for damages and recourse claims are excluded.

With this general consent, I/we further agree that all declarations and notices, and indeed all correspondence from Frankfurt School, shall be addressed and sent for all intents and purposes directly to my/our child.
